

## **PRECIOUS METALS, PRECIOUS STONES AND THEIR ARTICLES**

### **SCOPE**

Any jewellery or another object which is completely or partly made of precious metals or their alloys.

## **MAIN REQUIREMENTS FOR ECONOMIC OPERATORS**

The main requirements for the selling of precious metal articles in Latvia are following:

- The place of commercial activity shall be registered at the Assay Office of Latvia,
- The items shall be hallmarked in the state authorised and independent assay institutions of the EU Member States, Swiss Confederation, Turkey and EEA countries,
- The items shall be labelled correspondingly.

## **REGISTER OF SALES POINTS FOR PRECIOUS METALS, PRECIOUS STONES AND THEIR PRODUCTS**

Before commencing the commercial activity with precious metals, precious stones and their products, the place of activity shall be registered in the Register of places for work with precious metals, precious stones and their products (Latvian language only) maintained by the "Latvijas proves birojs", VSIA (Assay Office of Latvia).

In order to register or update information in the Register, an application shall be submitted to the "Latvijas proves birojs", VSIA (Assay Office of Latvia) in accordance with the Cabinet Regulation No. 367, adopted August 20, 2002 "Registration procedure for places of commercial activity for work with precious metals, precious stones and their products, a procedure for compulsory assaying and marking and a procedure for the storage of unassayed precious metals, precious stones and their products".
